

## AGREEMENT FOR RELEASE AND HOLD HARMLESS

The undersigned acknowledges the inherent risk involved in riding and working around horses which risks include bodily injury from using, riding or being in close proximity to horses among other risks, and further that both horse and rider can be injured in normal use, foxhunting or in competition and schooling. This agreement constitutes notice to the undersigned of the intrinsic dangers of equine activities.

The undersigned does hereby agree to (i) release, hold harmless and indemnify Hunters Chasers LLC, George P Kingsley and Karen Nutt (collectively, "Indemnitees") and (ii) further release them from any liability or responsibility for accident, damage, injury or illness to (i) the undersigned, (ii) any horse owned by the undersigned, or (iii) any family member, friend, guest or spectator accompanying the undersigned on or off the premises of 8500 Oak Spring Road, Upperville Virginia.

I fully understand that riding, cross-country horse back riding and foxhunting (which includes riding over fences, other obstacles and steep and rough terrain) are intrinsically very dangerous activities. **I fully understand that riding is a very dangerous activity with many inherent risks including: (i) the propensity of an equine to behave in dangerous ways which may result in injury to the rider, trainer, groom or handler, (ii) the inability to predict an equine's reaction to sound movements, objects, persons or animals, and (iii) hazards of surface or subsurface conditions and riding over unknown terrain where hazards may be hidden by vegetation or development. I wish to participate in these activities knowing they are intrinsically dangerous. I accept and assume all the risks of injury (including death) to my property, my horse, any family member, friend, guest or spectator or me.**

In exchange for being permitted to participate in these activities for myself, my heirs, guardian, and legal representatives, I release and agree not to make or bring any claim of any kind against the Indemnitees of any of them, for injury (including death), to me, my horse, any family member, friend, guest or spectator or any damage to my property whether from anyone's negligence or not, or any other cause, arising out of my participation in these dangerous horseback riding, fox hunting or related activities; and I also agree if anyone makes any claims because of any injury to me (including death), or for any damage to my property, I will keep all Indemnitees free of any damages, costs, claims or liability resulting from such claims. My signature hereby indicates my agreement to wear a hard hat at all times while riding at Oak Spring Farm and to obey all rules set forth by Hunters Chasers LLC.

This release shall remain valid unless expressly revoked in writing by the undersigned or his or her parent or guardian, if a minor.
